

17. DIRECTIONS TO THE SITE

The Project would extend a 733 mile pipeline from a point near Prudhoe Bay in the North Slope Borough (NSB) south to the Mat-Su Borough and connect into ENSTAR's distribution system at MP 39 of the Beluga Natural Gas Pipeline southwest of Big Lake. Approximately 30 miles of new, 12-inch-diameter pipeline (Fairbanks Lateral) would diverge from the proposed mainline 2.5 miles south of the mainline Chatanika River crossing at MP 440 and would extend through the Yukon-Koyukuk Census Area (YKCA) and Fairbanks North Star Borough (FNSB).
